Mandatory Handling

All flights with MTOM above 3500 kg are subject to mandatory

handling. Flights below 25 tonnes MTOM can choose between Basic and Exclusive handling. All flights with MTOM above 25 tonnes are subject to Exclusive handling.

Remarks: Outside AD Operational hours Rescue and Fire Services for position- and cargo flights PPR 72 hours.

AO Operational Assistance

For flights departing from Billund Airport the flightplan handling, ATS messages and briefing package are included in Basic and Exclusive Handling.

Surcharge Handling Tariffs; Passenger Flights

Airport opening hours are 06.00–22.00 local time. Between 23.01–05.00 an additional night surcharge on 75 % of Basic handling will be charged.

1 Cancellation of scheduled flights:

- 1.1 Less than 48 hours prior to scheduled departure 40 % of basic handling will be charged.
- 1.2 Less than 24 hours prior to scheduled departure 50 % of basic handling will be charged.
- 1.3 Less than 12 hours prior to scheduled departure 75 % of basic handling will be charged.

Payment

Unless a specific agreement has been made with Billund Airport A/S, all services are to be paid by cash or by creditcard.

Liability and Indemnity

The Handling Company shall not be liable for damage sustained by or claims lodged against the Carrier in connection with the performance of the services or supply of goods, if any, irrespective of how and by which persons such damages are caused, unless such damages or claims are due to gross negligence or willful misconduct of the Handling company, its servants or subcontractors.

The Carrier shall indemnify the Handling Company against and hold the Handling Company free and harmless from all claims (including all costs incident thereto) instituted by or on behalf of the Carrier's passengers, employees, shippers or consignees if these claims arise from or are connected with the performance of the services or the supply of goods by the Handling Company unless such claims are due to gross negligence or willful misconduct of the Handling Company, its servants or subcontractors.
